Security Update

Thank you for your sincere responses to the security survey. Your responses have been reviewed by the administration and the school board. Admin has reached out directly to many of the parents who had questions, concerns or suggestions. We have also added members from our FCS family to our enhanced Security Task Force.

The majority of families and teachers responded in favor of having armed security on campus moving forward. Therefore FCS will continue moving forward with implementing additional security measures up to and including hiring internal and/or external security personnel. Some of the things that are being considered are; enhanced training and increased involvement in the CCW program for teachers and staff, hardening of doors/solid doors/door armor, enhancements to our security camera system, swipe key entry and further community engagement. The hiring of security personnel at our school campuses is not a decision that will be taken lightly, nor will we rush into the decision. The security task force will begin interviewing companies, having on site visits and obtaining recommendations from experts in the field. Our goal at this point is to have security in place for the 24/25 school year.

We appreciate your support and welcome your prayers as we move forward in improving our security measures and ensuring our students' well-being.

Development

2024-2025 Tuition Fee Schedule

Here is how to re-enroll: You will need to open, complete, and submit the financial agreement in the instructions emailed out from FACTS (to be sent out Dec 1, also available in the portal Dec 1). Questions, please email stanton@flagchristian.org. You must pay the registration fee on FACTS. Your student is NOT considered re-enrolled until the payment plan is set up and the application AND fee are paid. Open Enrollment for non FCS students will start Jan 1, and on Feb 1 they will be eligible to be in a class for those that have not re-enrolled.

The FCS Board has decided the tuition schedule for the 2024-25 school year is as follows:

For you, as the table below shows, re-enrollment runs from December 1 through February 1st. The fees for re-enrollment are \$150 per current student if re-enrolled, with enrollment fees paid, by February 1st. If you have more than one child, you will enroll a minimum of one on FACTS and then will have to log in to enroll other siblings. Their spot will be held for 2 weeks at which point it could be released. For example, \$150 may be paid for one child prior to February 1st, the next child will need to be signed in and re-enrolled and paid for by February 15th, and child three by March 1 (additional children at 2 weeks per child). After February 1st (or if a deadline for a sibling isn't met), the re-enrollment fee also increases to \$250 per student.
